**BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE
BID (SCRB) AND RECOMMENDING APPROVAL AND AWARD OF
CONTRACT FOR THE PROCUREMENT OF ONE (1) UNIT BRAND NEW
ASIAN UTILITY VEHICLE (AUV)**

BAC RESOLUTION NO. 2019-12-016

WHEREAS, the Bureau of Local Government Finance, Department of Finance, Regional Office No. VIII, advertised the Invitation to Apply for Eligibility and to Bid for the Procurement of one (1) unit Brand New Asian Utility Vehicle (AUV) in the PhilGEPS, BLGF Website's transparency seal, and in conspicuous places within the premises of the BLGF Regional Office for twelve (12) calendar days;

WHEREAS, this Office, is going to procure one (1) unit motor vehicle to transport the staff and personnel in the conduct of treasury/assessment evaluations to the different LGUs in Region VIII and other official transactions appertaining the Office, this region;

WHEREAS, Region VIII generally experiences rainy weather half/mid of the year requiring a well-covered vehicle to transport sufficient number of employees/personnel comprising of evaluation teams in pursuit of the preceding paragraph of its purpose;

WHEREAS, in response to the said advertisement, two (2) bidders attended the Pre-Bid Conference on November 27, 2019, the Toyota Tacloban, Leyte Inc., Tata Motors and one observer from the three (3) invited observers;

WHEREAS, the deadline of the submission of bids is on December 9, 2019 at 10:00 AM wherein only one bidder submitted the bid documentary requirements, which is Toyota Tacloban, Leyte Inc.;

WHEREAS, the bid opening was conducted on the same day December 9, 2019 at 2:00PM. The BAC was able to send the invitation letter to the two (2) Observers namely: CSO and NGO. However, during the bid opening the BAC has found out that they have erred to notify the COA and/or inadvertently overlooked to send the already prepared letter invitation to the COA for the later to act as Observer. At

this point, we immediately call the Auditor's Office informing the honest mistake committed by the BAC.

WHEREAS, the BAC recommended to the HOPE to invoke Section 41.b (reservation clause) of RA 9184;

WHEREAS, the HOPE through its letter dated December 9, 2019 instructed the BAC to proceed with the Procurement Process.

WHEREAS, on December 10, 2019, during the preliminary evaluation of the Bid Proposals of the lone Bidder, it was rated "Passed" and declared "Eligible". Hence, in accordance with Sec. 32 of the same IRR, such bid previously pronounced by the BAC as "Eligible" has to be examined and scrutinized under the process of Detailed Evaluation/Examination of Bids to objectively consider the completeness of the bid.

WHEREAS, below is the result of the opening and evaluation of its financial and technical proposals, viz:

WHEREAS, on December 11-12, 2019, the TWG conducted a Post-Qualification to verify, validate and ascertain the authenticity and genuineness of all statements and documents submitted by Toyota Tacloban, Leyte Inc., pursuant to Section 34 of the Revised IRR of RA 9184;


WHEREAS, in a meeting scheduled in the herein date, the TWG presented its Post-Qualification Report to the BAC, and has duly verified that all the Eligibility, Technical and Financial statements of the said bid are responsive to the requirements for this bidding;


WHEREFORE, in consideration of the foregoing, the BAC RESOLVED AS IT IS HEREBY RESOLVES to adopt and approve the recommendation of the TWG, and declare that the bid of Toyota Tacloban, Leyte Inc. with a calculated financial proposal of One Million Two Hundred Ninety-Eight and Twenty Pesos (P 1,298,020.00) as the Single Calculated and Responsive Bid;


