BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL AND AWARD OF CONTRACT IN THE OPENING OF BIDS FOR THE PROCUREMENT OF ONE (1) UNIT BRAND NEW ASIAN UTILITY VEHICLE (AUV), ENGINE DISPLACEMENT NOT EXCEEDING 2800CC, DIESEL TYPE, ENGINE NOT EXCEEDING FOUR (4) CYLINDERS.

WHEREAS, the Bureau of Local Government Finance, Department of Finance, Regional Office No. VIII, re-advertised the Invitation to Apply for Eligibility and to Bid for the Procurement of one (1) unit Brand New Asian Utility Vehicle (AUV) in the PhilGEPS, BLGF Website's transparency seal, and in conspicuous places within the premises of the BLGF Regional Office for twelve (12) calendar days;

WHEREAS, this Office, is going to procure one (1) unit motor vehicle to transport the staff and personnel in the conduct of treasury/assessment evaluations to the different LGUs in Region VIII and other official transactions appertaining the Office, this region;

WHEREAS, Region VIII generally experiences rainy weather half/mid of the year requiring a well-covered vehicle to transport sufficient number of employees/personnel comprising of evaluation teams in pursuit of the preceding paragraph of its purpose;

WHEREAS, the AUV's structure is more suitable in carrying out the functions and transactions of the Regional Office;

WHEREAS, the Pre-Bid Conference was conducted on January 2, 2020 at 10:00AM, no bidder attended, only one observer attended from the three (3) invited observers;

WHEREAS, in response to the said advertisement, one (1) bidder submitted their bid;

WHEREAS, on January 14, 2020 at 2:00PM the scheduled opening of the Bids, only one (1) Bidder submitted the Bidding documents, the Toyota Tacloban Leyte, Inc., it was attended by their representative and the two (2) observers: the COA and from the NGO.

WHEREAS, Toyota Tacloban Leyte, Inc., submitted their bid, rated passed the preliminary examination of bids, complied the necessary and the order of requirements;

WHEREAS, in the Post Qualification Evaluation Report, the Toyota Tacloban Leyte, Inc. was rated responsive and passed both the Technical and Financial qualifications;

WHEREAS, Toyota Tacloban Leyte, Inc., as lone bidder rated to be the Single Calculated and Responsive Bid (SCRB);

WHEREAS, below is the result of the opening and evaluation of its financial and technical proposals, viz:

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


