For the information, guidance and compliance of all concerned, quoted hereunder is the full text of the Memorandum dated September 15, 2011 of the Executive Director, this Bureau, relative to the 2009 eSRE Report posted in the BLGF Website, to wit:

"This is to inform that all submitted/uploaded and reviewed reports for CY 2009 in excel format generated by the eSRE Report Generator and thru the eSRE Web System as of June 30, 2011 are now posted in our website.

"In this connection, you are hereby directed as follows:

- "1. Require all LGUs within your jurisdiction to submit their 2009 eSRE web report
- "2. Review thoroughly the 2009 eSRE web report submitted by the LGUs
- "3. Impose administrative sanctions on treasurers who failed to submit their 2009 eSRE reports.

"Hereunder are the scheduled deadlines on the submission of the said reports.

- a. Municipality to Province - September 28, 2011
- b. Province and City to Regional Office - October 19, 2011
- c. Regional Office to Central Office - October 31, 2011

"All reports must be submitted to the Central Office on or before October 31, 2011. After the said date, the list of LGUs with no eSRE report shall be posted in the website."

In this connection, the Provincial and City Treasurers, this Region, are hereby instructed to comply with the directive contained in the said Memorandum, particularly the complete submission of the 2009 eSRE Reports within the prescribed deadlines.

The Provincial Treasurers, this Region, are hereby instructed to disseminate copies of this Circular to the Municipal Treasurers within their respective jurisdictions.

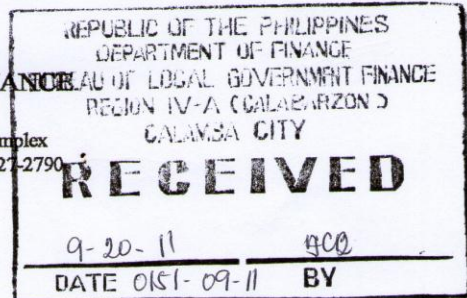


