NOTICE OF PAYMENT OF THE 1% BASIC PROPERTY TAX
AND 1% SPECIAL EDUCATION FUND TAX
FOR CALENDAR YEAR 2016

Notice is hereby given that pursuant to the provisions of Republic Act No. 7160 of the Local Government Code of 1991, specifically Section 233, 250 of the Code, the one percent (1%) Basic Real Property Tax and the additional one percent (1%) Special Education Tax for the calendar year 2016 may be paid in four (4) installments without interest at the option of the taxpayers, as follows:

- 1st Installment _____ on or before March 31, 2016
- 2nd Installment _____ on or before June 30, 2016
- 3rd Installment _____ on or before September 30, 2016
- 4th Installment _____ on or before December 31, 2016

The one percent (1%) Basic tax and the additional one percent (1%) Special Education Fund tax shall be collected simultaneously. A Ten percent (10%) discount on the total tax due for both BASIC and SEF shall be granted to taxpayers who pay within the prescribed period herein set forth. A twenty percent (20%) discount for advance payment shall likewise be granted.

Failure to pay the said tax on or before the dates indicated above, shall subject the taxpayers to a penalty at the rate of two (2%) for each month of delinquency, but not to exceed 36 months or seventy two (72%). After the end of the year for which the taxes are due and real property taxes are not paid, the administrative remedies provided for in the code to enforce the collection thereof shall be availed of by this Office.

Owners of real property/ies or persons having legal interest therein are requested to pay their taxes at the Offices of the respective Municipal Treasurer where their property/ies are located.
