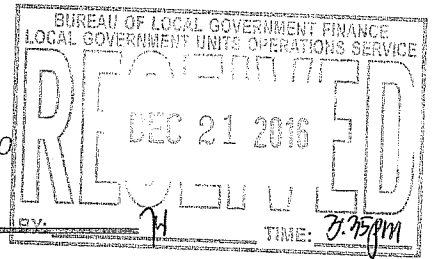

**NOTICE OF PAYMENT OF REAL PROPERTY TAX  
 FOR CALENDAR YEAR 2017  
 IN THE PROVINCE OF ILOCOS NORTE**

Pursuant to the provisions of Provincial Tax Ordinance No. 2013-001 otherwise known as the Revised Revenue Code of 2013 of the Province of Ilocos Norte, notice is hereby given that the payment of basic real property tax which is 1% of the assessed value of real property and an additional 1% of Special Education Tax (SEF) for the year 2017 in the Province of Ilocos Norte shall be within four (4) equal installments without interest, as follows:

1 <sup>st</sup> Installment	-	on or before March 31, 2017
2 <sup>nd</sup> Installment	-	on or before June 30, 2017
3 <sup>rd</sup> Installment	-	on or before September 30, 2017
4 <sup>th</sup> Installment	-	on or before December 31, 2017

If full payment of the aforementioned tax is made in advance, the taxpayer shall be granted a discount of twenty percent (20%) if full payment is made on or before January 01, 2017 and a fifteen percent (15%) discount if full payment is made on or before January 16, 2017 and if full payment is made not later than March 31, 2017 a ten percent (10%) discount is granted. If the payment of said taxes is made on installment basis, no discount is granted.

Failure to pay both the basic tax and special education fund tax on or before the expiration of the period above-stated shall subject the taxpayer to the payment of interest at the rate of two percent (2%) per month on the unpaid amount until the delinquent tax have been fully paid, provided, however, that in no case shall the total interest on the unpaid tax exceed thirty six (36) months.

After the expiration of the time required to pay both the basic real property tax and SEF tax, this office shall avail of the remedies allowed by law to enforce the collection thereof thru levy on real property or at public auction.
