NOTICE OF PAYMENT OF REAL PROPERTY TAX IN ALAMINOS CITY FOR THE CALENDAR YEAR 2018

Notice is hereby given to all real property owners in Alaminos City that pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991 and Local Tax Ordinance No. 21-2001, 2002-21 and 2008-07 of the City of Alaminos, the basic real property tax on real property at the rate of one percent (1%) on the assessed value of residential, commercial, industrial and special properties plus an additional one percent (1%) for the Special Education Fund (SEF), shall become due and payable on the first day of January 2018, the said taxes may however be paid in four (4) equal installments without interest at the option of the taxpayers, which is as follows:

| 1 st Installment – on or before March 31, 2018 |
| 2 nd Installment – on or before June 30, 2018 |
| 3 rd Installment – on or before September 30, 2018 |
| 4 th Installment – on or before December 31, 2018 |

Taxpayers with no delinquency, who shall pay their real property tax in full for the year 2018 on or before December 31, 2017, are entitled to a TWENTY PERCENT (20%) DISCOUNT and those who opt to pay on the first quarter (January 2, 2018 – March 31, 2018) are entitled to a FIFTEEN PERCENT (15%) DISCOUNT.

Upon the expiration of the periods given, an interest of TWO PERCENT (2%) per month not to exceed THIRTY SIX (36) MONTHS or SEVENTY TWO PERCENT (72%) shall be impose upon delinquent properties for failure to pay the basic and SEF real property tax or any other tax levied under our Local Tax Ordinance.

After the expiration of the time required to pay the basic real property tax and SEF real property tax, this office shall avail of the remedies allowed by law to enforce the collection thereof.
