**Notice of Payment of 1% Basic Real Property Tax and 1% Special Education Fund Tax in the Province of Lanao del Norte for the Calendar Year 2019**

Notice is hereby given that pursuant to Section 233 Chapter 4, Section 235, Chapter 5, Section 246, 250 and 251, Chapter 6 of Republic Act 7160, otherwise known as the Local Government Code of 1991, having been adapted and embodied in an enabling Provincial Tax Ordinance No. 002-2015 known as the Revised Provincial Revenue Code of Lanao del Norte of 2015. The Basic Real Property Tax and Special Education Fund Tax for Calendar Year 2019 at the rate of One Percent (1%) each shall become due and payable on the first day of January, the said taxes maybe paid in four (4) installment without interest at the option of the taxpayer, as follows:

| 1 <sup>st</sup> Installment | - on or before March 31, 2019     |
| 2 <sup>nd</sup> Installment | - on or before June 30, 2019      |
| 3 <sup>rd</sup> Installment | - on or before September 30, 2019 |
| 4 <sup>th</sup> Installment | - on or before December 31, 2019  |

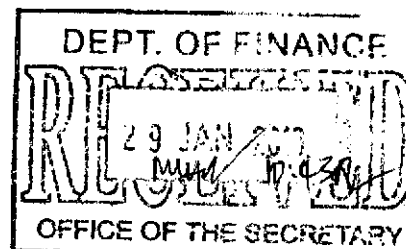
The 1% Basic Tax and additional 1% Special Education Fund Tax shall be collected simultaneously.

A 10% discount shall be granted to taxpayers who pay in full taxes on or before the deadline stated above and 20% discount of Annual Tax due for the succeeding year 2019 if taxes are paid within the year 2018 based on the Latest Assessment.

Failure to pay real property taxes for Basic and Special Education Fund Tax on or before the scheduled date of payment shall subject the taxpayer to penalty of Two Percent (2%) for each month of delinquency as provided, however, that in no case shall the total interests on the unpaid tax or portion thereof exceeds thirty-six (36) months.

Administrative and legal remedies guaranteed for by law to enforce tax collections will be availed of by this Office on delinquent taxes which have remained unpaid at the end of the year.

Owners on real property or persons having legal interests therein are requested to pay their taxes at the Office of the Municipal Treasurer where the properties are located or at the Provincial Treasurer's Office, Capitol, Tubod, Lanao del Norte.
