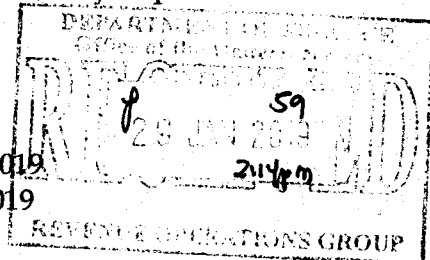

**NOTICE OF PAYMENT OF THE 1% BASIC REAL PROPERTY TAX
AND ADDITIONAL 1% SPECIAL EDUCATION FUND
TAX IN THE PROVINCE OF PALAWAN FOR
CALENDAR YEAR 2019**

Notice is hereby served that pursuant to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, specifically Property Tax and the additional one (1%) Special Education Fund Tax for the Calendar Year 2019, may be paid in four (4) equal installment without penalty, viz;

- 1st Installment on or before March 31, 2019
- 2nd Installment on or before June 30, 2019
- 3rd Installment on or before September 30, 2019
- 4th Installment on or before December 31, 2019

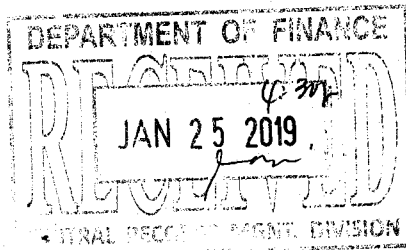


The one percent (1%) Basic Tax and additional one percent (1%) Special Educational Fund Tax shall be collected simultaneously. Ten percent (10%) discount for the prompt payment on the total tax due for quarterly payments, but the 10% discount shall be forfeited failure to pay within the first (1st) quarter and twenty percent (20%) discount on the total tax due for advance payment shall be granted to taxpayers who pay in the preceeding year under 72 of the New Revenue Code of the Province of Palawan, **PROVINCIAL TAX ORDINANCE NO. 1285-12, Series of 2012 as amended by Provincial Ordinance No. 2015 Series of 2018., "AN ORDINANCE AMENDING SECTION 72 OF PROVINCIAL ORDINANCE NO. 1285, SERIES OF 2012 TO CONFORM WITH SECTION 251 OF REPUBLIC ACT 7160 - GRANTING 20% TAX DISCOUNT FOR ADVANCE PAYMENT OF REAL PROPERTY TAXES"**.

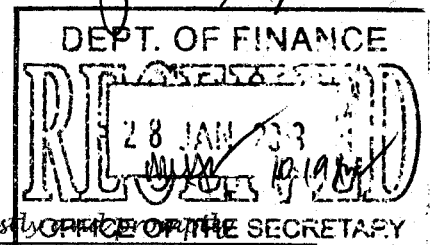
Failure to pay the said tax on or before the dates indicated above, shall subject the taxpayers to the payment of interest at the rate of two percent (2%) for each month of delinquency, until the delinquent taxes shall have been fully paid. After the expiration of the time required to pay the real property taxes, institution of the civil or administrative action provided for in the Code to enforce the collection thereof will be availed of by this office.

Payment of such taxes shall be made in the Office of the Municipal Treasurer where the properties are located, or in the Office of the Provincial Treasurer of Palawan.
