**NOTICE OF PAYMENT OF THE 1% BASIC REAL PROPERTY TAX
AND ADDITIONAL 1% SPECIAL EDUCATION FUND TAX IN THE
PROVINCE OF SIQUIJOR FOR THE YEAR 2019**

Notice is hereby given to all real property owners that pursuant to the provisions of the Local Government Code (R.A. 7160) and the Provincial Revenue Code of Siquijor, the payment of the Basic tax on real property, which is 1% of the assessed value of the real property and the additional 1% levied for the Special Education Fund for CY 2019, is due and payable on the 1st day of January 2019. The same may however be paid in four (4) equal installments without interest or penalty, at the option of the taxpayer, as follows:

- 1st installment** - **on or before March 31, 2019**
- 2nd installment** - **on or before June 30, 2019**
- 3rd installment** - **on or before September 30, 2019**
- 4th installment** - **on or before December 31, 2019**

Both the Basic Tax and the additional 1% SEF tax shall be collected simultaneously.

Prompt payment shall be given a discount of ten percent (10%) while advance payment shall be entitled to fifteen percent (15%) discount of the tax due in accordance with the schedule of payment prescribed above.

Failure to pay the basic real property tax and the additional SEF tax on or before the dates indicated above shall subject the taxpayer to the payment of interest at the rate of two percent (2%) per month on the unpaid amount or fraction thereof, until the delinquent tax shall have been fully paid. Provided, however, that in no case shall the total interest on the unpaid tax or portion thereof exceed thirty-six (36) months or seventy two percent (72%).

Owners of real property in all municipalities of the province of Siquijor or persons having interest therein are requested to pay their taxes within the period as prescribed herein and payment shall be made at the Office of the Municipal Treasurer where the properties are located.

The province may avail of the remedies for the collection of delinquent real property taxes by administrative action through levy on real property, sale of real property by public auction or by judicial action as provided in the Code.
