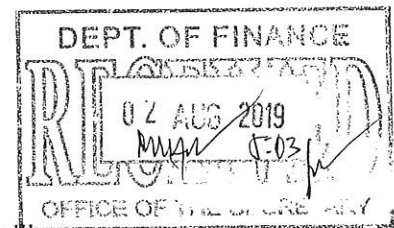

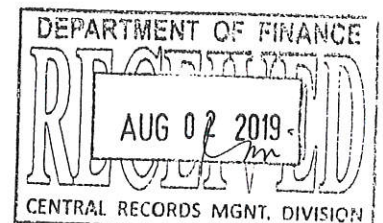

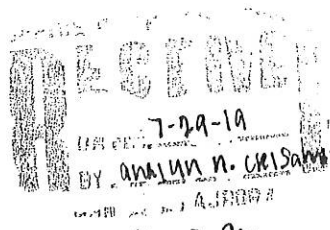
- 1) I am the Treasurer of Barangay Zarah, San Luis, Aurora.

- 6) I am executing this affidavit to attest to the truth of the foregoing facts and for whatever legal purpose it may serve.


