**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND
RECOMMENDING AWARD TO TOYOTA BAGUIO CITY FOR THE PROCUREMENT AND
DELIVERY OF ONE BRAND NEW MOTOR VEHICLE,**

WHEREAS, the Bureau of Local Government Finance- Cordillera Administrative Region (BLGF-CAR) is authorized to procure one (1) unit of Brand New Motor Vehicle under the FY 2019 General Appropriations Act (GAA) RA 11260 in the amount of One Million Three Hundred Thousand Pesos (Php 1,300,000.00).

WHEREAS, the brand new motor vehicle is intended for the official use of the Regional Director and Staff in the conduct of Revenue and Assessment Evaluation, Investigation, attendance to meetings, trainings and other official business in relation to the implementation of programs and policies on local treasury and assessment in the LGUs of CAR;

WHEREAS, under Budget Circular No. 2012-1 dated March 04, 2019, Annex B- Revised Motor Vehicle Classification and Specification Guide for AUV and CUV, and for the above stated purpose, allows the procurement of motor vehicle with engine displacement not exceeding 2500cc gasoline or 2800cc diesel;

WHEREAS, the BLGF-CAR posted its Invitation to Bid, including the Bidding Documents in the PHILGEPs, and in conspicuous places to invite bidders for the procurement of the motor vehicle. The BLGF-CAR under its Bidding Documents, intends to procure a Brand New Motor Vehicle (Asian Utility Vehicle) with engine displacement not exceeding 2800cc Diesel/Manual;

WHEREAS, in response to the said Invitation to Bid, only one (1) prospective bidder bought bidding documents and submitted their bid prior to the scheduled deadline of submission;

WHEREAS, upon opening of bid/s on October 21, 2019 at 2:03pm, Toyota Baguio City, was found eligible to bid for the procurement of One (1) Brand New Motor Vehicle and passed the preliminary evaluation of eligibility documents using a non-discretionary "pass/fail" criterion. TOYOTA Baguio City is doing business for and on behalf of TOYOTA Dagupan City, Inc. per SEC Registration Number AS094-006185. Present in the opening of bid/s are observers in the person of Ms. Lilibeth Belgica, Auditor from Commission on Audit and Ms. Nora Antonio from TG Home Builders;

WHEREAS, TOYOTA Baguio City submitted a bid price for the One (1) Brand New Motor Vehicle with engine displacement of 2800cc Diesel Manual Transmission in the amount of One Million Three Hundred Thousand Pesos Only (Php 1,300,000.00), which is in conformity with the Approved Budget of the Contract (ABC).



- c. To recommend the issuance of Notice to Award and Notice to Proceed, accordingly to TOYOTA Baguio City for having successfully complied and passed all the bid requirements.




