**NOTICE OF PAYMENT OF REAL PROPERTY TAX FOR THE
 CALENDAR YEAR 2020**

Notice is hereby given that pursuant to the provisions of Sections 249 and 250 of Republic Act. No. 7160, otherwise known as the Local Code of 1991, payment of the basic tax on real property at the rate of one per centum (1%) per annum and an additional one per centum (1%) for the Special Education Fund tax for the Calendar Year 2020 shall become due and payable on the first day of January, 2020. Said taxes, however, may be paid in four equal installments without interest or penalty, as follows;

- 1st Installment - on or before March 31, 2020
- 2nd Installment - on or before June 30, 2020
- 3rd Installment - on or before September 30, 2020
- 4th Installment - on or before December 31, 2020

The one percent (1%) Basic Tax and the additional one percent (1%) SEF Tax shall be collected simultaneously. **Prompt payment shall be given a discount of ten (10%) while advance payment shall be entitled to twenty (20%) discount of the tax due** in accordance with the schedule of payment prescribed above.

Failure to pay real property taxes for both the basic tax and Special Education Fund tax on or before the dates indicated above shall subject the taxpayers to a penalty of two per centum (2%) for each month of delinquency, until the tax is fully paid but not to exceed 36 months. If at the end of calendar year, payment of the taxes has not been effected, the summary remedies to enforce collection will be availed of by this Office.

Payment of the said taxes shall be made at the Office of the Municipal Treasurers where the properties are located, or in the Office of the Provincial Treasurer.

**NOTICE OF DELINQUENCY IN THE PAYMENT OF
REAL PROPERTY TAX FOR CALENDAR YEAR 2020**

Notice is hereby served pursuant to the provisions of Section 254 of the Local Government Code of 1991 (Republic Act 7160) that the Real Property Tax Due and payable for CY 2020 has become delinquent with respect to the following:


1. The 1st Installment thereof becomes delinquent as of the 1st day of April, 2020;
2. The 2nd Installment, as of the 1st day of July, 2020;
3. The 3rd Installment, as of the 1st day of October, 2020;
4. The 4th Installment, as of the 1st day of January, 2021;

Under Section 174 of the above-stated Code, the undersigned is empowered to resort to any of the following civil remedies to enforce collection, to wit:

1. By administrative action thru distraint of personal property, Section 175, Levy on real property (Sections 176 & 258) and sale at public auction (Sections 178 & 260).
2. By judicial action in any court of competent jurisdictions (Sections 183 & 266).

Section 255 provides: "...failure to pay the Real Property Tax... upon expiration of the periods as provided in Section 250... shall subject the taxpayer to the payment of interest at the rate of two percent (2%) per month on the unpaid amount or a fraction thereof, until the delinquent tax shall been fully paid...."

Delinquent taxpayers are therefore requested to pay their delinquent taxes and penalties due, the soonest time possible in order to forestall the institution of the above-mentioned remedies.
