## NOTICE OF PAYMENT FOR CALENDAR YEAR 2020

### REAL PROPERTY TAX

#### QUARTERLY PAYMENTS PROMPT PAYMENTS (with 10% disc.)

- 1<sup>ST</sup> installment – on or before January 20, 2020
- 2<sup>ND</sup> installment – on or before April 20, 2020
- 3<sup>RD</sup> installment – on or before July 20, 2020
- 4<sup>TH</sup> installment – on or before October 20, 2020

#### QUARTERLY PAYMENTS (WITHOUT PENALTY)

- 1<sup>ST</sup> installment – on or before March 31, 2020
- 2<sup>ND</sup> installment – on or before June 30, 2020
- 3<sup>RD</sup> installment – on or before September 30, 2020
- 4<sup>TH</sup> installment – on or before December 31, 2020

**IDLE LAND** – One percent (1%) of the Assessed Value

#### MAYOR'S PERMIT/ BUSINESS TAX

- 1<sup>ST</sup> installment – on or before January 20, 2020
- 2<sup>ND</sup> installment – on or before April 20, 2020
- 3<sup>RD</sup> installment – on or before July 20, 2020
- 4<sup>TH</sup> installment – on or before October 20, 2020



### NOTICE TO DELINQUENT REAL PROPERTY TAXPAYERS

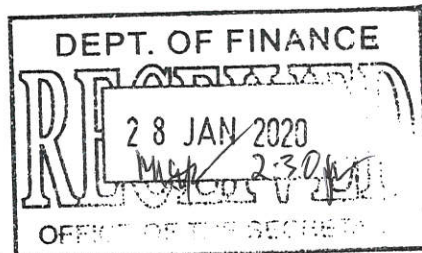
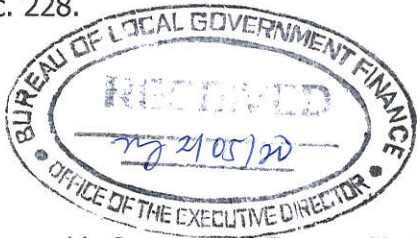
Notice is hereby given to all delinquent real property taxpayers of the City of Bacoor who failed to pay the real property taxes on or before the scheduled day of tax payments. Failure to pay the basic real property tax and special education fund tax shall subject the taxpayers concerned to an interest of two percent (2%) per month of delinquency provided in Section 255 of the Local Government Code.

Payment of real property taxes shall first be applied to prior years delinquencies, interest and penalties, if any, and only after said delinquencies are settled may tax payment be credited for the current period in accordance with Section 250 of the Local Government Code.

Furthermore, Section 258, provides, "After the expiration of the time required to pay the Real Property Tax . . . real property subject to such tax may be levied upon through the issuance of a warrant on or before, or simultaneously with the institution of the Civil Action for the collection of the Delinquent Tax xxx".

Owners of new real properties or properties that remained untransferred are respectfully requested to submit a copy of Deed of Sale or other documents evidencing transfer to the Office of the City Assessor together with the supporting documents for the official transfer of properties.

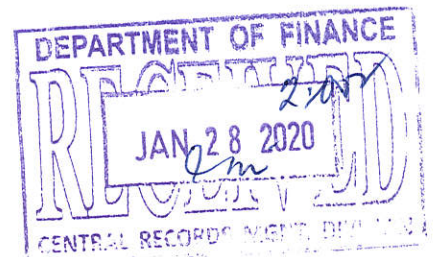
