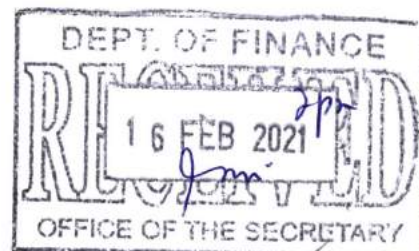

5. That despite all efforts, I was not able to find said **Tax payer's copy, auditor copy and treasurer's copy of said Community Tax Certificate (3 sets) with Serial Nos. 13801151 and 13801152** and it is now beyond recovery;
