**AFFIDAVIT OF LOSS**



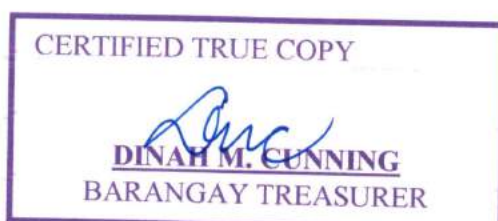
1. I am the barangay treasurer of Soquib, Besao, Mountain Province.


1. We are among the Barangay Officials of Suquib, Besao, Mountain Province.
