## BLGF REPORT ON ITS 8TH QUARTERLY LGRP PROGRESS REPORT

As of end September 2022, the BLGF has achieved a physical accomplishment rate of 14.29%, which is a quarter-on-quarter increase of 1.50% from the preceding quarter. The notable progress for this period was brought about by the various project management activities of the LGRP and the approval of the Terms of Reference (TOR) for the Computer Assisted Mass Appraisal (CAMA) with Geographical Information System (GIS) and the Real Property Information System (RPIS). Figure 1 below presents the project's progress for this period.



The major accomplishments regarding the LGRP project management activities include the (i) deployment of the LGRP Transition Planning workshop, (ii) approval of the FY 2022 Annual Work and Financial Plan [AW&FP], (iii) issuance of the Project's 1st quarterly newsletter, and (iv) approval of the Stakeholder Engagement and Communication [SEC] plan.

There have been considerable activities that were conducted which contributed to the overall physical performance of the project from the remaining Project Outputs. These project activities include dynamic coordination and collaboration with implementing and other partner agencies of government. With these developments taking place, both the ADB and the BLGF are optimistic that subsequent progress will pick up the pace to attain the overarching objective of fiscal decentralization, that would bring down local fiscal transfer dependencies of the LGUs and gradually move towards increasing domestic resource mobilization, that will fuel a more robust and resilient economy at the local level.

Table 1 presents the significant movement in LGRP respective project outputs and project management activities. It would be noted that the project management contributed 61.14% to LGRP's progress while 38.86% is an aggregation of all the Project Output physical performance as of Quarter 3 of 2022.
