NOTICE OF PAYMENT OF THE 1% BASIC REAL, PROPERTY TAX
AND ADDITIONAL 1% SPECIAL EDUCATIONAL FUND
TAX IN THE PROVINCE OF PALAWAN FOR THE YEAR 2024

Notice is hereby given to all real property owners that pursuant to the provisions of Local Government Code (R.A. 7160), the payment of the Basic tax on real property, which is 1% of the assessed value of the real property and the additional 1% levied for Special Educational Fund Tax for the Calendar Year 2024 is due and payable on the 1st day of January 2024. The same may however be paid in four (4) equal installments without interest, at the option of the taxpayers, as follows:

1 st Installment		on or before March 31, 2024
2 nd Installment		on or before June 30, 2024
3 rd Installment		on or before September 30, 2024
4 th Installment		on or before December 31, 2024

Both Basic Tax and the additional one percent (1%) Special Educational Fund Tax shall be collected simultaneously.

Prompt payment shall be given a discount of ten (10%) of the tax due in accordance with the schedule of payment prescribed above while advance payment shall be entitled to (20%) discount of the tax due before the schedule of payment prescribed above.

Failure to pay the basic real property tax and the additional tax on or before the dates indicated above shall subject to the payment of interest at the rate of two percent (2%) per month on the unpaid amount or fraction thereof, until the delinquent tax shall have been fully paid. Provided, however, that in no case shall the total interest on the unpaid tax or portion thereof exceed thirty six (36) months or seventy two percent (72%).

Payment shall be made in the office of the Municipal Treasurer where the properties are located, or in the Office of the Provincial Treasurer of Palawan.
