NOTICE OF PAYMENT OF 1.25% BASIC REAL PROPERTY TAX AND 1% SPECIAL EDUCATIONAL FUND IN TANJAY CITY FOR THE YEAR 2024.

NOTICE is hereby given that pursuant to Section 233, Chapter 4, Section 235, Chapter 5, Section 246 and 251, Chapter 6 of Republic Act 7160, otherwise known as the Local Government Code of 1991, the payment of Real Property Taxes in this City without penalty for the current year is on March 31, 2024. The 1.25% of Basic Real Property Tax and 1% Special Education Fund Tax for the Calendar Year 2024, maybe paid in four (4) equal installments without interest at the option of the taxpayer, as follows:

1 st installment	-on or before March 31, 2024
2 nd installment	-on or before June 30, 2024
3 rd installment	-on or before September 30, 2024
4 th installment	-on or before December 31, 2024

The 1.25% Basic Tax and the additional 1% Special Educational Fund Tax shall be collected simultaneously. A 20% discount of total tax due shall be granted to taxpayers who pay whole year tax on or before January 31, 2024, 15% discount on the total tax due shall be granted to taxpayers who pay the whole year tax on or before February 28, 2024 to March 31, 2024, and 10% discount for those taxpayers who pay quarterly tax on or before the prescribed period dates mentioned above, provided however that there is no tax delinquency on the said property.

Failure to pay the said taxes on or before the dates indicated above shall subject the taxpayer to an interest at the rate of 2% per month on the unpaid amount of fraction thereof, but not to exceed 36 months or seventy two(72%) percent. After the end of the year for which the taxes are due and real property taxes are not paid, the remedies provided for by the law to enforce collection thereof will be availed by this office)e.

Real property owners with the jurisdiction of Tanjay City having legal interest therein are requested to pay their taxes at this office within the period as prescribed herein.
