WHEREAS, the Bureau of Local Government Finance (BLGF) Bids and Awards Committee (BAC), through its Administrative Division–Property Section, posted its Invitation to Bid (ITB) for the Procurement of Janitorial Services for FY 2025;

WHEREAS, the approved budget for the Contract is Two Million One Hundred Pesos (₱ 2,100,000.00)

WHEREAS, the complete schedule of activities for the said project is as follows:

WHEREAS, during the pre-bidding conference held on November 15, 2024, one (1) prospective bidder participated namely, Starcom Manpower and Allied Services, Inc. (STARCOM);

WHEREAS, on November 29, 2024, 12:00 noon, bidder STARCOM has submitted on time their proposal while Cancu Enterprises and General Services, Inc. submitted their bid at 12:15 p.m., beyond the deadline, and was declared ineligible in accordance with the Implementing Rules and Regulations (IRR) of the Republic Act (RA) 9184;

WHEREAS, upon careful evaluation of the BAC-Technical Working Group, as stated from their Bid Evaluation Report, the bid of STARCOM is not compliant with Section 9 (b) II of the Department of Labor and Employment (DOLE) Department Order Number 18-A;

The total contract cost offered by STARCOM is Php 2,099,590.92.

However, it is noted that Agency Fee is not compliant with Section 9 (b) ii of Department of Labor and Employment Department Order No. 18-A which provides that "Section 9. Required contract under these Rules. - xxx The Service Agreement shall include the following: xxx ii. The place of work and terms and conditions governing the contracting arrangement to include the agreed amount of the services to be rendered, the standard administrative fee of not less than 10 percent (10%) of the total contract cost (emphasis supplied).

STARCOM's agency fee computation is only Php1,557.01 instead of the supposed amount of Php2,076.007. Thus, with a difference of Php518.997

WHEREAS, under Section 35 of the 2016 Revised IRR of RA 9184 provides that the BAC shall declare the bidding a failure when:
